

## **END USER LICENCE**

**SHARED BAND SOFTWARE HAS BEEN PRE-INSTALLED ON THE ROUTER OR CAN BE DOWNLOADED FROM SHARED BAND'S WEBSITE ([WWW.SHAREDBAND.COM](http://WWW.SHAREDBAND.COM)) OR THE WEBSITE OF YOUR SHARED BAND SERVICE PROVIDER . BEFORE YOU DOWNLOAD THE SOFTWARE OR USE THE ROUTER CAREFULLY READ THE TERMS AND CONDITIONS OF THIS LICENCE. BY DOWNLOADING, COPYING, INSTALLING OR OTHERWISE USING THE SOFTWARE YOU AGREE TO BE BOUND BY AND ARE BECOMING THE LICENSEE TO THIS LICENCE WHICH CONSTITUTES A LEGALLY BINDING CONTRACT BETWEEN THE LICENSEE ("YOU") AND THE LICENSOR, SHARED BAND LIMITED, (HEREINAFTER REFERRED TO AS "SHARED BAND").**

### **1. LICENCE AND GRANT**

- 1.1 In this Licence, Software means the object code versions of the Shared Band Software Modules and all associated media, printed materials, "online" or electronic documentation and bundled software.
- 1.2 The Software is not sold but licensed to You for use only in accordance with this Licence. Shared Band transfers no title to or ownership in the Software to You or any third party and Shared Band reserves all rights not expressly granted to You.
- 1.3 If You do not agree to the terms of this Licence You must not use the Software and must immediately delete any and all copies of the Software in Your possession.
- 1.4 Shared Band hereby grants You a non-exclusive licence to use the Software subject to the following conditions.
- 1.5 You may transfer the Software or otherwise make it available to third parties provided always that you procure that the person to whom the Software is transferred accepts the terms of this licence prior to making any use of the Software by visiting Shared Band's website ([www.sharedband.com](http://www.sharedband.com)) or the website of Your Shared Band service provider and following the on-screen instructions for registration and acceptance of an end user licence.

### **2. LICENCE FEE**

- 2.1 There is no licence fee payable by You for use of the Software.
- 2.2 Certain modules of the Software are open source and can be redistributed and/or modified under the terms of Version 2 of the GNU General Public Licence as published by the Free Software Foundation. Such modules are distributed in the hope that they will be useful, but without any warranty or even the implied warranty of merchantability or fitness for a particular purpose – see the GNU General Public Licence (Version 2) for more details. ### **3. YOUR OBLIGATIONS**

- 3.1 By accepting this Licence You undertake:-
  - 3.1.1 not to use, exploit or copy the Software except as agreed by Shared Band or expressly set forth in this licence;

- 3.1.2 not to disclose, make available or use the Software for the benefit of any third party, nor to sell, assign, lease, rent or otherwise commercially exploit the Software with or without charge;
- 3.1.3 not to copy, modify, translate, decompile, disassemble or otherwise reverse engineer the Software nor to permit the whole or any part of the Software to be combined with or become incorporated in any other programs or otherwise determine or attempt to determine source code or protocols from the executable code of the Software or create derivative works based upon the Software;
- 3.1.4 not to use the Software for immoral, illegal or for any other purpose which may be termed abusive or harmful;
- 3.1.5 within 14 days after the date of determination or discontinuance of this Licence for whatever reason to destroy the Software and all upgrades or copies.

#### 4. **INTELLECTUAL PROPERTY RIGHTS**

- 4.1 The Software is protected by copyright and other intellectual property laws and international treaties. Title to, ownership of, and all rights and interests to any and every part of the Software and all copies thereof shall remain at all times vested in Shared Band.

#### 5. **NO WARRANTY**

- 5.1 You acknowledge that the Software is still under development and that it is provided “as is” without any warranty express or implied including but not limited to the implied warranties of satisfactory quality, fitness for a particular purpose, title and non-infringement. Shared Band does not warrant that the Software will be error-free or that such errors will be corrected and You are solely responsible for all costs and expenses associated with the rectification, repair or damage caused by such errors.
- 5.2 Shared Band may create new versions of the Software (“Upgrades”) which may correct such errors and although Shared Band has no obligation to notify existing licensees of such Upgrades, the same will be made available free of charge.
- 5.3 Shared Band shall not be liable to You or any other party for any loss or damage arising directly or indirectly in connection with this Licence, the Software, its use or otherwise except to the extent that such liability may not be lawfully excluded under the applicable law. In particular, Shared Band accept no responsibility for any losses arising from You installing the Software on Your computer or router.
- 5.4 Notwithstanding the generality of clauses 5.3 above, Shared Band expressly excludes liability for indirect, special, incidental or consequential loss or damage howsoever arising.

#### 6. **TERMINATION**

- 6.1 You may terminate this Licence at any time by destroying the Software, documentation or copies. Shared Band may terminate this Licence at any time if You are found to be in breach of any of the terms of this Licence or if Shared Band is notified by Your Shared Band service provider that any subscription for the provision of a line or lines is overdue. If You are notified of such termination You must comply with the provisions of clause 3.1.6 above.
- 6.2 Shared Band reserves the right to disable the Software without this resulting in termination of the Licence upon the occurrence of any one of the events described in clause 6.1 above.

#### 7. **LAW**

This Licence shall be governed in all respects by English law and You agree to submit to the exclusive jurisdiction of the English courts.
